 - b. Responsibilities of DELAC Advisory committee for the district's EL program. Including qualified teachers, redesignation plan, needs assessment, state mandated forms for parents
 - c. Information on distribution of funds (A. Cruz) We are not using the LCAP this year. The new funding plan will focus on addressing student needs during distance learning. This includes how to help students with attendance problems, learning loss, and at risk students. Application for Categorical Programs-funds are used for different needs 1. Title #1-money for students who are struggling or are not at grade level. Support can be given in the form of afterschool programs, aides, and counselors 2. Title #2 provides funds for professional developments for teachers and administrators We currently do not know the amount of funds the district will receive this year. Title #3: (Part 1 for English Learners) Last year the district received \$159,000. Funds are used to support ELs in academic achievement. Part 2 of Title III

funds are used for immigrants students that move around. Our district receives services through Kern County Supt of Schools. One such support is Migrant classes that are held on Saturdays. Title #4 funds are set aside for assisting students with social and emotional needs. Some supports the district offers are counselors at each school site and a district social worker. MUSD has also applied for a safety and protection equipment program fund. Funding from this source will ensure that students and teachers remain safe when we return to on campus instruction.

- d. Needs Assessment results A survey was sent digitally to all parents at the end of May. 239 responses were received. From these responses, the top 5 will be addressed throughout this year's DELAC meetings. These include: 1. I am aware of the district's English Language Development instructional plan. 2. I understand how to help my child with schoolwork. 3. I am aware of resources for parents in my own language. 4. I know what my child needs to do to be considered proficient in English. 5. I am aware that parents of English Learners can take classes to learn English through the McFarland Learning Center.
- e. EL Student Data Mrs. Soto reviewed the district's reclassifications guidelines (needs survey item 4) with parents. These include: score of 4 on the ELPAC, Teacher evaluation, Parent opinion, student performance. She also went over the past two years of EL data. In Spring 2019, 1,344 students took the ELPAC compared with 1,240 in Spring 2020. In 2019, 207 MUSD students were reclassified from EL to RFEP compared with 144 as of August 2020.
