Superintendent's Report:

Superintendent Gabriel McCurtis welcomed new board member Jim Beltran and reelected board member David Arguello. He added that he and Kaye Breyer, David Arguello and Marlin Isaacs had attended the Winter Trustees Workshop Dinner. The topic of discussion was the Budget Crisis. Mr. McCurtis also stated that he had attended the California School Boards Association's Annual Education Conference along with board members Marlin Isaacs, David Arguello, Kaye Breyer and Jim Beltran. Marlin Isaacs had also attended the Board Presidents Workshop and Jim Beltran also attended the New Board Members Workshop. He and Kaye Breyer also attended the Legal Symposium. They attended many meaningful workshops including some regarding the state budget. Supt. McCurtis also added that the Groundbreaking Ceremony was held at MMS for the new Central Kitchen. Supt. McCurtis added that he had visited Sacramento with Steve Samuelian from California Consulting and had met with Tom Torlakson. They had discussed a new elementary school and he invited Mr. Torlakson to visit MUSD.

Mr. McCurtis asked Jeff Foy to give an update on the current projects. Jeff stated that the ribbon cutting ceremony for the two story classroom building was held earlier today with many in attendance. He also stated that work has begun on the Central Kitchen.
