**Advance Planning**

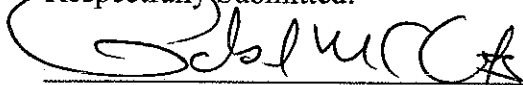
The next Regular Board Meeting date of April 12, 2011 was previously approved at the March 8<sup>th</sup> 2011 Board Meeting.


**Adjournment**

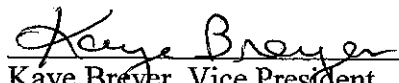
Motion made by David Arguello, seconded by Kaye Breyer to adjourn the meeting. Motion carried by a 4-0 vote.
