		The District has determined that it is in its best interests to pursue additions to the School District through the lease-leaseback method of project delivery pursuant to California Education Code §17406 which permits the governing board of the District, without advertising for bids, to lease to the LLB Entity owned by the District if the instrument by which property is leased requires the lessee to construct, or provide for the construction, on the leased premises, of a facility for the use of the District during the term of the lease, and provides that title to that building shall vest in the District at the expiration of the lease. The District issued an RFQ for a lease-leaseback provider and after consideration of th responses, selected S.C. Anderson, Inc. as the Lease-Leaseback Entity. The staff has entere into negotiations with S.C. Anderson for pre-construction services during the design phase of the Project. These negotiations have been completed and have resulted in the attached contract. The Pre-Construction Services Price for performance of the work by S.C. Anderson is Fifty Thousand Dollars (\$50,000.00). This is a guaranteed maximum price and is a component of the overall Guaranteed Maximum Price for the entire project. Staff recommends that the District authorize the Superintendent to enter into the Pre-Construction Services Agreement with S.C. Anderson, Inc. in substantially the form attached hereto a Exhibit A.
