## **Community Input**

Rafael Melendez addressed the board regarding a personal matter.

Chris Breyer addressed the board with comments regarding all the progress being made in the district.

### Superintendent's Report:

#### 1. Attendance

Superintendent McCurtis asked Quentin Panek to give a brief update of the ACSA Special Education Symposium he attended last week. Mr. Panek stated that he attended many workshops and roundtable discussions some of which included Brain Research, Co-Teaching, Top 10 Pitfalls of Special Ed. & what to expect as a Director of Special Ed. in a new district.

Superintendent McCurtis asked Kim McManaman to give the board information regarding the new Kindergarten Transition to be put in place next year. She stated that the Transition will be implemented for the upcoming school year. Students at age 5 by November 2 will be enrolled in Kindergarten for the 2012-2013 school year. They will identify the students who qualify as well as work with the parents who will be affected by the transition.

Mr. McCurtis added that at the Budget Meeting scheduled for Wednesday they should know more about the transition requirements.

He also stated that he and Ambelina had attended a meeting last Friday at the county office regarding the Transportation Trigger that will affect the district by approximately \$80,000. He also added that Governor Brown's Budget is based on taxes and if not passed will cause the need for more cuts.

Supt. McCurtis also asked Ty Bryson from MHS and Louie Gomez from MMS to come forward to be addressed. He stated that they are two of the finest principals in the District and are doing great at their school sites.

He asked David Lopez, Director of Technology to come forth and also stated that David has been implemental in the districts growth in Technology. Items such as all elementary classrooms having Smartboards with surround sound and computers. All classrooms at MMS having Smartboards as well and all but 6 classrooms at MHS have Smartboards. David also mentioned each classroom has projectors and there are multiple labs at MMS and MHS. He added that the visitors from Peru are implementing many similar items after visiting our district.

Supt. McCurtis added that the Nursing Program at the McFarland Learning Center should be opening soon.

Supt. McCurtis and Board President Kaye Breyer presented former board President Marlin Isaacs with a Plaque in Appreciation of his leadership as Board President.

Supt. McCurtis also stated that Margie Perez at the FRC is doing a commendable job and that the recent audit had no findings.

Supt. McCurtis stated that the monthly total was 3281 students enrolled for the month. Last month there were 3287 and one year ago there were 3238 students.

## **Board Member/Student Board Member Reports**

Student Board Member Erika Garza gave her report. She stated that the first semester ended and all students studied for finals. The Senior class studied and also had to submit all UC and CSU applications before the deadline in November. In the next few months Seniors will be filling out applications forr scholarships, financial aid and grants. Many of the teachers assisted with the application process. She thanked them for their help and said she hopes to make them proud one March comes around and they know where the Seniors will be headed in the fall.

Student Board Member Khlarissa Agee stated that beginning in December, the winter sports began their pres-season. All sports consisting of wrestling, soccer and basketball participated in tournaments before the winter break. Today, both girls and boys Varsity Soccer teams will battle their first conference match her at home against Farmersville High School. Tomorrow, all four basketball teams will travel to Laton High School to begin their season. JV and Varsity Wrestling will compete in Shafter High later in the week. Winter Sports have gotten off to a great start and hope to gain many more victories and accomplishments.

In Support Services they provide Emergency Food Pantry and Emergency Utility and Rental Assistance. They are funded by First Five till 2013 and MUSD.
