## Superintendent's Report:

Superintendent Hopper:

1. Attendance report: to date we have 3458 students, 1 month we had 3340 and 1 year ago we had 3385. Superintendent Hopper reported on District happenings: He thanked Cristina Tafoya and her staff for being proactive in targeting parents to complete the applications by attending the Back to Schools & staying late in the evenings. Mr. Hopper also reported that Kern Avenue concerns regarding the workroom and copy machines are being addressed as well as brighter exit lights in the MPR. He met with Amy Bean, Executive Director of the North Kern Vocational Training Center with a focus on agricultural and health-related careers. He also has been invited to attend the MMS ASB Officer Installations on Friday morning. On Wednesday, the McFarland Animal Shelter personnel will be picking up the surplus items as approved by the board. He

congratulated the Governing Board and Mrs. Duran and her team for the County approval of our LCAP multiyear projections and assumptions. This is a result of the hard work of the C & I Team. He also congratulated Mr. Bryson and Mr. Lopez for a great review from QUEIA for Kern Avenue and Browning Road Schools meeting the requirements for 2013-14. He added that September is Attendance Awareness month and the need to educate parents and guardians that attendance is very important. He also reported that he will be attending in Collaboration with the McFarland Lions Club and the FRC Program the "Stuff the Bus" event on September 20<sup>th</sup> at the Dollar General parking lot from 9-2:00 p.m. This is an annual campaign to collect school supplies for needy children in our school district. FRC Program Manager Margie Perez will be recording a Public Service Announcement in English and Spanish.
