Community Input

Manuel Cantu addressed the board regarding BP 4040 and stated concerns he and staff had with the revisions to the policy. He stated he would like to have more collaboration and discussion with regards to the policy

Superintendent's Report:

Superintendent Hopper:

1. Attendance report: Currently the enrollment is at 3452 with an increase of 102 students from last year.

Superintendent Hopper also reported: *State Board of Equalization – regarding regulations and LCAP. With the end-result being, increased transparency and student input. Also regarding Gift Limitations for Public Officials-we received a reminder from Schools Legal Service the importance of keeping track of any and all gifts from vendors. That the \$50 reporting threshold is a cumulative one (\$440 per year): gifts from a particular source must be reported when the total of all gifts from the source equals or exceeds \$50 in the calendar year. The Fair Political Practices Commission sometimes subpoenas the records of vendors and compares them to the Forms 7000 filed by district officials listed in the vendor's records to see if the reporting is accurate. The 15th Annual Kern County Teacher Recruitment Fair is scheduled for Saturday, April 11, 2015 at the Larry E. Reider Education Center from 8-noon.

Superintendent Hopper also recognized Outgoing Board Member Irene Lopez for her time on the School Board. He and the board thanked her and presented her with a plaque and flowers. She was an asset to the McFarland Unified School Board. He also welcomed new trustee Victoria Ramirez. He also congratulated all district staff for its commitment to expanding access to Advanced Placement coursework - while improving student performance- which earned the district a spot on the 5th Annual AP® District Honor Roll. He thanked all the teachers who are participating as RCD Leads, on the Mathematics Adoption Committee and/or the Report Card Committee. He thanked Ms. Socorro Robles, Ms. Timpson, & Ms. Ortega for stepping up to help with the MYPAAS activities. He welcomed Brenda Hernandez to the District. He thanked the BR & KA teachers for their input on RCD. The RCD and DATA teams continue to meet. Mr. Hopper also announced the coordination of a safety presentation with CHP Officer Robert Rodriguez scheduled for Dec. 9th. Also, an invitation to visit Cal Poly San Luis Obispo has been extended by Ana Garcia of UC Merced. On another note, new copy machines have been delivered and installed thanks to LCFF monies; NKVTC notified us of the term expiration for Jim Beltran. Also, CSBA has a call for nominations to CSBA Delegate Assembly until Wednesday, Jan. 7, 2015. In conclusion he thanked all of the parents for entrusting us with their child's education and a big thank you to Ambelina Duran for her hard work and diligence in ensuring another successful financing to help ensure the completion of the new elementary school. He also thanked all staff members & board members for their hard work and dedication and wished everyone a Happy Thanksgiving.
