## **Superintendent's Report:**

Superintendent Hopper reported on:

- 1. Attendance To date the District has 3424 students enrolled, 70 more than last year.
- 2. Superintendent Hopper also reported on these items: He recognized Maria Perez, Coordinator of Special Projects, for getting an increase in Migrant Funding to extend Saturday School for 3 extra days, he thanked the math committee members for their commitment to excellence in giving their time and talents to ensure that math textbooks meet our student's needs, and finally, praise to all the parents, staff, administration, students and board president for coming together to highlight some of the talent we have in MUSD,

- especially at MHS when Jack Mitchell, CDE Secondary Arts Consultant came to evaluate our programs as part of the Golden Ribbon Award screening process, Congratulations to Alan Navarro being selected to represent MUSD as Teacher of the Year 2014-15 at the County Level, and finally Congratulations to Mr. & Mrs. Albert Melendez who celebrate their 42<sup>nd</sup> wedding anniversary.
- 3. Regarding updates Superintendent Hopper reported that Assemblywoman Shannon Grove would like the board to review a copy of the K-12 Education Legislative Package from the California Assembly Republican Caucus. He also stated that State Superintendent Torlakson extended an invitation to CSEA, MTA, Trustees and himself to attend California's first Labor-Management Initiative Symposium. (an event focused on improving student education through labor-management partnerships, scheduled for May 8 & 9, 2015 in San Diego and must be attended as a district team: Supt., MTA President, CSEA President and a board member.

Student board member Arturo Navarrete reported on Academics: MHS is planning many upcoming events which include a Food Day (vendors come to the school to sell), CAHSEE Academy in wrapping up, and ASB held a mini sports assembly/rally informing the student body of current sports program details at MHS. Also, regarding Athletics: Winter Sports are almost complete, with all sports doing amazingly. All won League except for Girls Varsity Basketball. Girls Soccer went to Valley but lost, Boys and Girls Basketball made it to the Second Round of Playoffs. Boys Soccer is playing their first round of Regionals.

- 1. NKVTC Amy Bean gave a powerpoint presentation regarding the North Kern Vocational Training Center Programs. It operates under a Joint Powers Agreement between three districts: McFarland, Delano and Wasco. She proceeded to explain the funding history, courses currently offered, and the Standards for Career Ready Practice which describes the knowledge and skills needed by students to prepare for transition to postsecondary education, career training, or the workforce. Jim McFarland, member of the NKVTC Board also spoke on behalf of
- 2. Facilities & Transportation Michael Doria gave an update on the current happenings in Transportation a New Bus purchased with a Grant funded 50% by SJVAPCD with the old bus being demolished as a condition of the Grant. He also reported on the New Elementary School currently being assembled/built with a tentative final completion date of Dec. 31, 2015. He shared a layout of the buildings and order of delivery of said buildings. Regarding the MHS Concession/Restroom building, it is almost complete. The fire alarm booster panel and plaque have been installed. Regarding the MMS Relocatable Project buildings to be moved and installed by August with funding from Developer Fees. The Painting Project for KA & BR will be bid out next month with work to be completed over the summer break. Costs will determine if one or both sites can be done this year. This project is funded with Deferred Maintenance monies. He added that Long Range Facilities Master Plan was awarded to CM Construction Services/Mangini Architects at last month's board meeting and contracts are being negotiated and scheduled for April September. He added regarding the Prop 39 Energy Performance that Climatec was selected. They will meet and schedule site assessments for the 5-year plan with year one being \$168,799. He also reported on School Dude and the Modules being implemented.
