B. Superintendent's Report

Superintendent Victor Hopper shared the following with the Board:

- 1. Attendance Report To date, the District has 3,550 students currently enrolled, one year ago there were 3,532, an increase of 18 students.
- 2. He recognized Browning Elementary School Principal Mr. Dario Diaz for his initiative and leadership in improving school attendance and increasing school funds.

C. Staff Reports

- 1. Deputy Superintendent
 - a. Deputy Superintendent Ambelina Garcia Duran addressed the Board and shared information regarding the Resolution to increase developer fees.
- 2. Assistant Superintendent
 - a. Assistant Superintendent Aaron Resendez addressed the Board and shared results relating to the accountability system in the State of California with the Board. He stated that the results are now available online and available to the public.
 - b. He announced that Monica Daniel and Vanessa DeLeon attended a CUE Conference that deals specifically with the utilization of technology and that they are both working to incorporate CUE Professional Development training for teachers, and in addition, will be holding CUE Professional Development training for site administrators.

- c. He invited Principal Dario Diaz to share his visit with a school that has a STEM Program and how he may be able to adopt that program in his school. Mr. Dario stated that at Browning Road Elementary, they abide by the four "C's" Communication, Collaboration, Creativity, Critical Thinking as the fundamental principles for designing lessons, STEM is the application of what has been learned. He has a staff that is passionate about making a difference and he looks forward to imbed this philosophy into their programs and share it with their students.
- d. Assistant Superintendent Aaron Resendez stated that Channel 29 News was on campus today and will feature MHS during their news hour and highlight MHS graduation success and overall accomplishments at the school.

 - a. Announced that on March 31st he had an opportunity to visit three sites. He stopped by Kern Avenue and he met with Principal Flores and sensed the enthusiasm from Mr. Flores and his staff. He then stopped to visit McFarland Middle School and met with Principal Cantu who greeted him as an ambassador of education. He learned valuable lessons on the MMS campus that he is taking to his current place of employment. To culminate his day, he went to McFarland High School and he was able to enjoy the hour with Principal Bell and students. He addressed Mr. Hopper and those in attendance and exclaimed that "it is all about the kids" and thanked the Principals for allowing him to visit. He stated that he intends to visit other sites at another time.

 - a. Wanted to take the opportunity to thank everyone for their prayers and thoughts for his daughter and son-in-law.
- 3. Board President Jim Beltran
 - a. Addressed the audience and thanked everyone for all that they are doing for our kids. He stated that everyone is doing a great job and he appreciates it. He hears reports from people in the community and that is where it is important. We are doing what we are here to do service our kids and give them the best possible education.

D. Approval of Resolution #1617-09 to increase Fee on Development Projects from \$3.48 to \$4.80 per square foot

The District has conducted a School Facilities Needs Analysis consistent with the requirements of Government Code section 65995.6 whereby the District has determined the need for school facilities to accommodate unhoused pupils that are attributed to projected enrollment growth from the development of new residential units over the next five (5) years. The District's School Facilities Needs Analysis results in a maximum alternative residential fee of \$4.80 per square foot of assessable residential construction.

Motion made by Angel Turrubiates, seconded by Eliseo Garza to approve Resolution #1617-09 to increase Fee on Development Project from \$3.48 to \$4.80 per square foot. Motion carried by 4-0 vote.

E. Approval of Resolution #1617-10 Calling for an Election Authorizing the Issuance of General Obligation Bonds of the District at an Election to be held July 25, 2017

The District is planning to ask the taxpayers to support a \$20 million bond measure under Proposition 46, which requires a 2/3 vote. The special election would be held on 7/25/17. The funds would be used "to build, renovate or expand new or existing school facilities and provide 21st century learning environments, reduce student overcrowding, increase classroom technology infrastructure, and upgrade vocational education facilities to prepare students for college and high-paying jobs after graduation." To offer our taxpayers additional assurances the district will add to the bond measure an independent Oversight Committee, annual audits, which are not required under Proposition 46. No money from the bond proceeds would be used for administrator salaries.

Motion made by Angel Turrubiates, seconded by David Diaz to approve Resolution #1617-10 Calling for an Election Authorizing the Issuance of General Obligation Bonds of the District at an Election to be held July 25, 2017. Motion carried by 4-0 vote.
