A. Approval of Personnel Register

B. Approval of Variable-Term Waiver for Katina Henry, 6th Grade Math Teacher at McFarland Middle School

Mathematics is a single subject area with few qualified teachers available to fill our existing positions. Ms. Henry is currently enrolled in a credential program and is eligible for a variable term waiver. She has been a substitute for this class and is requested to stay in this position for the remainder of the school year. This position will be re-posted for the next school year. Your approval is requested.

C. Approval of Resolution 0708-05

The resolution is required to correct timeline issues as identified by STRS in relation to the 2006-2007 Early Retirement Incentive Program. Approval is requested.

D. Approval of Joint Use Agreement with McFarland Recreation and Park District.

The purpose of this agreement is to provide for cooperative use of School District and Recreation District fields and facilities at no cost other than the direct utilities and maintenance/custodial costs.

E. Approval of Application for Part-Day State Preschool Programs

The California Department of Education (CDE), Child Development Division (CDD), is pleased to announce the availability of State Preschool (CPRE) funds for fiscal year (FY) 2007-08. The CPRE funds will provide direct services for California children ages three to five. The intent is for the MUSD to apply for \$183,341.00 from the state to open another Preschool in McFarland. Approval is requested.

F. Approval of Agreements between McFarland Unified School District and the following Supplemental Educational Service Providers: A+ Educational Centers, Academic Tutoring Services, Carney Educational Services, National Farm Workers Services Center Field, Fresno CORALIhc.DBA CORAL & Extreme Learning

On January 8, 2002, President Bush signed his education plan, No Child Left Behind, into law. The law united both political parties behind the principle that schools must be held accountable for their results and that every child must learn. As part of that law, when a disadvantaged child is attending a low performing school, federal funds can be used to provide supplemental services for that child. Parents of eligible children can choose from the list of state-approved providers. When parents have made their selection, the District must then contract with that provider to deliver the services. The law requires that supplemental education service providers adhere to high-quality, research-based instruction. The law states that a provider must continue to provide SES to eligible students until the end of the school year in which those services were first received. Approval is requested.

This is an annual report that is required by the CDE as a condition of continued funding. Approval is requested.
