XIII. Old Business

A. Approval of Resolution #0708-09, Requesting the Board of Supervisors of Kern County to Issue and Sell General Obligation Bonds of McFarland Unified School District, (Kern County, California) Election of 2004, Series 2008C.

Request approval of Resolution #0708-09, per bond counsel. This resolution allows us to issue bonds.

B. Approval of Resolution #0708-10, Providing for the issuance and sale of 2008 Refunding General Obligation Bonds of the District in the aggregate principal amount of not to exceed \$3,000,000 to refund the District's 1998 General Obligation refunding and approving related documents and actions.
