#### **Presentations**

1. Reading First - Valerie Garcia & Valerie Perez

Valerie Perez and Valerie Garcia gave a power point presentation regarding the district's Reading First Program. They stated the Major Components: Reading First is established under the Federal No Child Left Behind Act, Improve K-3 classroom instruction in reading so that by the end of third grade, all students are grade level proficient readers in English, and The California Reading First Plan calls for the use of one of two current State adopted, scientific research and standards-based English reading/language arts instructional programs – MUSD uses SRA Open Court.

2. Recognition of Reclassification of LEP Students - Teresa Arvizu

Teresa Arvizu gave a brief summary of the Reclassification process. She stated that school districts are to develop student reclassification policy and procedures based on the four criteria set forth in the reclassification guidelines approved by the State Board of Education (Ed. Code Section 313(d)). The four criteria can be used by school districts/schools when evaluating a student's readiness for reclassification from English learner (EL) to fluent English Proficient (RFEP). The criteria are: Assessment of English Proficiency, Comparison of Performance in Basic Skills, Teacher Evaluation of Student Academic Performance, Parent or Guardian Opinion and Consultation and the last step is Reclassification. She then proceeded to present the Certificates of Reclassification to the students present. The Board Members, staff and community applauded the students and as well as their parents for their great accomplishment. Fifty – seven students were awarded certificates.

#### **Information and Proposals**

#### **Community Input**

Melissa Melendez Martinez on behalf of the Student Support Services Dept. as the Community Advisory Committee Representative of the district addressed the board. She stated, "We invite you to our Special Education Self Review Meeting. This is a meeting for parents and guardians of Special Education students. This will be a chance for them to tell us about the special education services their child has had. We would like to hear about what they think works and what areas could be made better. The parent or guardian meeting is an important part of the California Dept. of Education's Special Education Self Review process for school districts. It is one way that school districts can examine their compliance with the law as stated in the Individuals with Disabilities Ed. Act (IDEA). This meeting is designed to gain as much information as possible from parents and guardians about key areas in the district's implementation of IDEA. The meeting will be held at the McFarland High School Multipurpose Room on Thursday, February 21, 2008, at 5 – 7:30 p.m. Dinner will be served to all who RSVP and their will be a raffle for those completing the survey. Also provided will be a supervised movie night for the children. She distributed an invitation to each of the board members and Supt. and asked if there were any questions and if they planned to attend the Self Review they could call Jackie Hernandez at the Student Support Services office. She thanked the board for their time.

#### **Superintendent's Report:**

Superintendent McCurtis gave the attendance report.

1. Attendance - Superintendent Gabriel McCurtis gave the attendance report in which he stated that the monthly total was 3145 students enrolled. One month ago there were 3198 and one year ago there were 3071 students. He is monitoring the district reports and it looks like the student body is going up and the district is not declining enrollment. That is a good thing. He continued that he had attended the Superintendent's Symposium and was able to meet with other superintendents. He stated, "We met with three members of the State Board of Education who is going to make recommendations on sanctions to school districts and we were able to address some of the positive things that we're able to address. Some of the positive things that we're doing in our district. One of the things I've found and I've learned is our Governor and one of the things that's strong on his agenda is to make sure students are achieving and its going down from him to the State Supt. coming through me. And so when you see some of the recommendations, especially the outside entities that we're having come in and we're going to be presenting tonight for you to move on, I highly recommend

that we move on them. One of the things they're saying and that's what the various districts can't understand, here's what we're doing so that we're moving forward. Because one of the sanctions that can happen if they see that we're not moving forward, they'll make some unilateral decisions and they'll give us directives in terms of what we should be doing. So, I think we're moving in the right direction and some of the organizations that we continually want to bring in, my recommendation is we continue to do that. I believe its March, sometime in Mid-March we will know the sanctions that have come down and what the sanctions will be for our school district." Supt. McCurtis thanked the Board President and the Board.

## **Board Member & Student Board Member Reports**

Israel Guerrero gave the report for McFarland High School. He reported on weekly activities for FFA for next week. He stated that CSF and ASB students will be participating in the Read Across America and read to the students at Browning Road School on February 29<sup>th</sup> for Dr. Seuss Birthday. He also added that on Wednesday, McFarland High School will have twenty-two Chinese foreign exchange students visiting. They will give them a small tour of the high school. The AP Literature Class will be going to Paris and Rome on March 13<sup>th</sup>. Regarding sports, Baseball started last week and the first game is in two weeks, Wrestling is going on to Divisionals, Soccer will have finals in Farmersville and they are seeded in 5<sup>th</sup> place. He will report back on their trip at the next board meeting.

Ramon Melendez – He thanked everyone that was present for attending the meeting and also thanked Teresa Arvizu and the parents for the work with the students and stated that it is great that they are improving.

- 1. MOT Dept. Robert Matheny gave a brief power point presentation regarding the MOT Dept. He listed the services that the dept. needs to provide as: Upkeep of all facilities, Provide a service that is an asset to the district, Insure safety at all sites, Communicate with administrators, Supt. and school board. Regarding Transportation the needs are: Home to school safety, Clean & safe vehicles & to insure that all students' needs are being met and are transported in a timely manner to insure no interruptions to their education will exist. In his Overview he listed these items: Needs of Dept.- Maintenance Personnel, Needs of Personnel Training, Facilities Aggressive action, Budget Work with CBO to insure that all money is spent to the benefit of the district and community, Change transfer personnel to position that will benefit the school site and the district & Insure that all school board members and Supt. goals are met with prompt action. He added that windows had been replaced at Kern Avenue School and also regarding an old Relocatable building at Browning Road that will be refurbished. The library has been put in place at Browning Road.
- 2. Migrant Dept. Sandra Espinoza gave a power point presentation in which she noted all the different aspects of the Migrant Education Program. The mission statement is: "The mission of the Migrant Education Program Region V is to provide leadership staff development and other services that empower the school community to provide appropriate supplemental educational opportunities to ensure that migrant students succeed in the basic curriculum". The goal of Migrant Education is to identify and recruit eligible migrant students in order to help them meet California and local standards for student achievement through educational instruction and health services, and For Migrant students to graduate

with a high school diploma. They service children: prek (0-5 yrs - 109 students, Browning Road School - 148 students, Kern Avenue School - 175 students, Middle School - 139 students, McFarland High School - 176 and OSY - 26 students. She stated the services available to Migrant families include: Extended Day Classes, PASS Program, Close Up Program, MEES Classes, Saturday School, Work Study Program, Summer Program which includes: Summer School, Summer Outreach and PASS Program. The offer Support Services: Medical/Dental Services & Social Services, Parent Education: Local and Regional Classes, Family Literacy: MEES and Academics/Leadership. Their parent advisory committee includes: Rogelia Medina - President, Imelda Juarez - Vice President, Leticia Castan - Secretary - Alma Medina – Treasurer and Maria Lopez – Sergeant at Arms. The Pac committee's goals are to actively participate in establishing goals, objectives and priorities of the Migrant Education Program for the McFarland Unified School District, Be actively involved in the planning and negotiation of program applications and Service Agreement and they meet 6 times during the school year. She stated that some of the parental involvement included: Parenting skills with Rocio Magallanez, Dr. Quispe, and Guest speakers. Also, PIQE Classes, Parenting Classes (FRC), Family project (Region), Leadership Skills like Proyecto PADRE (Region) and Family Literacy with Latino Family Project and Family Storyteller (Region). Staff Development includes Project Write, Thinking Maps, Lit ART, Excel Math, Summer Outreach Training, MEES/MELA Meetings @ County Office and Identification and Recruitment Conference (Sacramento). Parents also attend PAC Meetings, RAC Meetings, Local CABE Conference (Fresno), Regional Parent Conference, MEES Conference and the State Parent Conference. She thanked the board for their support.
