Community Input

Raul Murrieta spoke regarding the elimination and cutback of the Ag Program and FFA at McFarland High School. He stated that if the Ag program is eliminated there won't be any Ag Science classes taught next year. He added that the Ag Program has been a long standing program in the community. He asked that the board look into it before making any decisions

Rick Sparks spoke regarding his concern on the readerboard and the amount of money to be spent on the purchase.

MaryAnn Rodriguez spoke in support of teacher Gerald Howze.

Superintendent's Report:

Supt McCurtis stated that the district is in the process of acquiring a new sound system for the board meetings. It should be ready by the next board meeting.

1. Attendance

Supt. McCurtis stated that the monthly total was 3208 students enrolled for the month. Last month there were 3184 and one year ago there were 3176 students. He added that the district is making attendance a priority. Also, the district loses ADA due to irregular student attendance.

He also added that he had met with Mr. Bryson and Kim McManaman at Kern Avenue and the special board meetings and study sessions will be held in room #74 at Kern Avenue from now on.

Board Member/Student Board Member Reports

Student Board member Jose Jaime reported that the Harlem Renaissance Festival was held on February 23 by Mrs. Rowland. He stated that all classes have started registering for next years classes. Also, Carly Marshall won the Lion's Club Zone level Speech Contest and will now compete at the region level which would be held in Bakersfield. The Spring Blood Drive was held on March 9th and it was a success.

Student Board Member Ezenia Garza reported on the winter sports. She stated that all four basketball teams got League and both Varsity teams were undefeated. The boy's soccer team did well and was co-champs with Farmersville. In wrestling, Jesus Urrea was 8th at Masters and was just one away from State. The team finished 4th in League along with Bakersfield Christian. The Spring Sports season is just starting. Congratulations went out to Round-bal Royalty winners: Jose Arreola and Kassie Gorman and to Soccer King and Queen: Rafael Serna and Stephanie Montes.

Marlin Isaacs reported that since the last board meeting he had attended a workshop on February 27th regarding the Brown Act and found it to be very interesting. He has also attended the North Kern Vocational Training Center board meeting and reported that MUSD is still in the running for the Firefighters Classes.

Kaye Breyer said she also attended the Brown Act workshop as well as the Institute for New Board Members held in February. She stated that she found it to be valuable information.

- 2. Reading First Valerie Perez, Valerie Garcia and Jasmine Reed were present to give a brief report regarding Reading First. They stated that the district began implementation of Reading First Program since the 2003-2004 school year and continues to implement the program today. Valerie added that the program was established under the federal No Child Left Behind Act. The goal of the Reading First Program is to improve K-3 classroom instruction in reading so that by the end of the third grade, all students are grade level proficient readers in English. David DeMille, Director, from R-TAC (Regional Technical Assistance Center) also addressed the board regarding Reading First. They do the monitoring and measuring for Reading First.
